

Planning a funeral is one of the hardest things you'll ever do, and the funeral industry knows it. The average funeral costs \$7,000-\$12,000, but most families don't know they can legally reduce these costs by thousands.

When my father passed away while I was deployed in the Navy, I was quoted \$12,000 for a basic funeral. Through research, I found I could do the exact same service for under \$3,000.

This guide will show you how to plan a dignified, meaningful funeral without overpaying. These are your legal rights under federal law.

Step 1: Understand Your Legal Rights (The FTC Funeral Rule)

The Division of Marketing Practices periodically issues informal staff advisory opinions in response to requests for interpretation of the Funeral Rule. Staff opinions are issued, pursuant to Rules 1.1-1.4 of the Commission's Rules of Practice, 16 C.F.R. §§ 1.1-1.4, in response to questions of general public interest.

Before you contact any funeral home, know your rights under the Federal Trade Commission's Funeral Rule:

Your Legal Rights:

- 1. Funeral homes MUST give you an itemized price list over the phone
- 2. You can buy a casket anywhere and they MUST accept it (no markup allowed)
- 3. Embalming is NOT required by law in most cases
- 4. You can decline ANY service you don't want
- 5. You have the right to see prices BEFORE seeing caskets or services
- 6. You can choose direct cremation or immediate burial

Why This Matters: Funeral homes often present certain services as "required" when they're not. Knowing your rights prevents manipulation during grief.

- 1. Print or bookmark the FTC Funeral Rule: ftc.gov/funeral-rule
- 2. Tell the funeral director you know your rights
- 3. Ask for the General Price List (GPL) immediately

Step 2: Choose Between Burial and Cremation

This is your first major decision and will determine your costs.

Direct Cremation:

- 1. Cost: \$800-\$2,000
- 2. Simplest option
- 3. No embalming required
- 4. No viewing or ceremony at funeral home
- 5. You receive ashes to scatter or keep
- 6. Can still have memorial service later

Immediate Burial:

- 1. Cost: \$1,500-\$3,000 (not including cemetery plot)
- 2. Simple burial without viewing
- 3. No embalming required
- 4. Graveside service option
- 5. Cemetery plot costs extra (\$1,000-\$4,000)

Traditional Funeral:

- 1. Cost: \$7,000-\$12,000+
- 2. Viewing/visitation
- 3. Embalming (usually)
- 4. Funeral service
- 5. Burial or cremation

Money-Saving Tip: Direct cremation is the most affordable option. You can still have a meaningful memorial service at a church, home, or outdoor location after cremation.

- 1. Discuss wishes with family
- 2. Consider religious/cultural requirements
- 3. Calculate what you can afford

Step 3: Shop for Caskets or Urns Online (Save \$2,000+)



This is where you'll save the most money.

The Markup: Funeral homes mark up caskets 300-500%. A casket that costs them \$600 gets sold to you for \$2,500-\$3,000.

Your Legal Right: Federal law requires funeral homes to accept ANY casket you purchase, without charging you extra for using an outside casket.

Where to Buy:

- Amazon: \$800-\$1,500 for quality caskets
 Costco: \$900-\$1,800 (membership required)
- 3. Walmart: \$795-\$2,000
- 4. Direct casket retailers online

For Urns:

- 1. Amazon: \$30-\$300
- 2. Etsy: \$50-\$400 (custom options)
- 3. Memorial Merits: Curated affordable options

What to Order:

1. Standard casket (steel or wood)

- 2. Delivered directly to funeral home
- 3. Order 2-3 days before service
- 4. Provide funeral home address for delivery

Money Saved: \$1,500-\$2,500 on casket alone

Action Items:

- 1. Search "caskets" on Amazon, wholesale retailers/partners, or Costco/Sam's Club
- 2. Read reviews
- 3. Order with 2-day shipping to funeral home
- 4. Inform funeral home you're providing your own casket

Step 4: Compare Funeral Home Prices

Funeral homes are REQUIRED to give you prices over the phone. Call at least 3-5 in your area.

What to Ask For:

- 1. "Can you email or text me your General Price List?"
- 2. "What is your fee for direct cremation?"
- 3. "What is your basic services fee?"
- 4. "Do you accept caskets from outside vendors?"

Price Comparison Checklist:

1. Basic services fee: \$1,500-\$2,500

Transportation: \$200-\$500
 Cremation fee: \$200-\$400
 Body preparation: \$200-\$700

5. Facility use: \$400-\$800

Red Flags:

- 1. Refusing to give prices over phone
- 2. Pressuring you to visit in person before sharing costs
- 3. Claiming certain services are "required" when they're not
- 4. Refusing outside caskets

Money-Saving Tip: The lowest price isn't always best, but knowing the range helps you negotiate and avoid overpaying.

- 1. Create a spreadsheet with 3-5 funeral homes
- 2. Call each and request their GPL
- 3. Compare basic services fees
- 4. Choose based on price AND professionalism

Step 5: Decide What Services You Actually Need

Many services presented as "necessary" are actually optional.

Actually Required by Law:

- 1. Filing death certificate
- 2. Transportation of body
- 3. Basic services fee (coordination)
- 4. Cremation or burial container

Optional Services (You Can Decline):

- 1. Embalming (unless viewing after several days)
- 2. Viewing/visitation at funeral home
- 3. Use of funeral home facilities
- 4. Limousine service
- 5. Guest book, memorial folders
- 6. Online obituary posting
- 7. Flower arrangements from funeral home

Alternative Options:

- 1. Hold memorial service at church (free or low cost)
- 2. Use your own guest book (\$20 vs. \$150)
- 3. Post obituary yourself online (free)
- 4. Order flowers from local florist or grocery store
- 5. Have friends/family transport in personal vehicles

Money Saved: \$1,000-\$3,000 by declining optional services

- 1. Review the GPL with family
- 2. Mark "must-have" vs. "nice-to-have" services
- 3. Decline anything not essential
- 4. Ask about holding service elsewhere

Step 6: Handle Death Certificates and Paperwork



You'll need multiple certified copies of the death certificate for various purposes.

How Many Copies to Order:

- 1. Banks/financial institutions: 2-3
- 2. Insurance companies: 2-3
- 3. Social Security: 1
- 4. Property transfers: 1-2
- 5. Vehicle titles: 1 per vehicle

Recommended: Order 10-15 certified copies initially

Cost: \$10-\$25 per certified copy (order through funeral home or vital records office)

Documents You'll Need:

- 1. Deceased's Social Security number
- 2. Birth certificate
- 3. Military discharge papers (if veteran)
- 4. Insurance policies
- 5. Deed/mortgage information


Paperwork Checklist:

- 1. Death certificate filed (funeral home handles)
- 2. Social Security notification
- 3. Bank accounts closed/transferred
- 4. Insurance claims filed
- 5. Property transfers initiated

Money-Saving Tip: Order all death certificates at once. Getting additional copies later costs more and takes weeks.

- 1. Request 10-15 certified death certificates
- 2. Gather all important documents
- 3. Create a checklist of notifications needed
- 4. Consider using a probate attorney for complex estates

Step 7: Plan a Meaningful Memorial Service on Budget



You don't need an expensive funeral home service to honor someone meaningfully.

Affordable Venue Options:

- 1. Church or place of worship (often free for members)
- 2. Community center (\$100-\$300)
- 3. Public park pavilion (\$50-\$150)
- 4. Private home or backyard (free)
- 5. Beach or natural setting (free)

Service Elements:

- 1. Eulogy (written by family/friends)
- 2. Photo slideshow (DIY with free tools)
- 3. Memory sharing time
- 4. Music (playlist on phone/speaker)
- 5. Guest book (buy online for \$20)
- 6. Simple refreshments (potluck or homemade)

DIY Memorial Ideas:

- 1. Create photo boards with printed pictures
- 2. Memory jar (guests write favorite memories)
- 3. Candle lighting ceremony
- 4. Release butterflies or biodegradable balloons
- 5. Plant a memorial tree

What You Don't Need:

- 1. Expensive flower arrangements (grocery store flowers work)
- 2. Professional videographer (friend with phone)
- 3. Printed programs (digital or simple home-printed)
- 4. Hired musicians (use meaningful recorded music)

Money Saved: \$2,000-\$4,000 by hosting service outside funeral home

- 1. Choose meaningful location
- 2. Assign tasks to willing family/friends
- 3. Create simple program or order of service
- 4. Prepare photo slideshow or memory boards

Step 8: Use Free Resources and Tools


