INTR	ODUCTION	
	ederal Trade Commission's Funeral Rule protects you from deceptive practices and ensures arent pricing. Use this checklist to understand and exercise your legal rights during funeral ng.	
✓ Y0	UR RIGHT TO TRANSPARENT PRICING	
Gene	ral Price List (GPL)	
•	☐ Request the General Price List immediately upon first contact	
•	☐ Review prices for ALL individual services and merchandise	
•	☐ Keep the price list for comparison (you don't have to return it)	
•	☐ Ask questions about any unclear pricing or fees	
•	☐ Compare prices from at least 2-3 funeral homes	
Cask	et and Outer Burial Container Price Lists	
•	☐ Request separate price lists for caskets and vaults BEFORE viewing merchandise	
•	☐ Review all available options from least to most expensive	
•	☐ Note that you can purchase these items from other suppliers	

## No Required Packages

•  $\square$  Confirm you can select individual items from the price list

•	☐ Decline any services you don't want or need		
•	☐ Ask for itemized pricing, not package deals		
•	☐ Verify that only direct cremation or immediate burial can be offered as required packages		
Purch	Purchase from Alternative Suppliers		
•	☐ Know you can buy caskets online or from third-party retailers		
•	☐ Know you can buy urns from any source		
•	☐ Confirm the funeral home CANNOT charge handling fees for outside purchases		
•	☐ Confirm the funeral home CANNOT require your presence when items are delivered		
•	$\square$ Verify the funeral home CANNOT refuse to use items you purchased elsewhere		
✓ YOUR EMBALMING RIGHTS			
Unde	rstanding When Embalming Is NOT Required		
•	☐ Know that embalming is NOT required by law in most cases		
•	☐ Ask about refrigeration as an alternative		
•	☐ Confirm the funeral home will NOT embalm without your permission		
•	☐ Verify no unauthorized embalming charges appear on your bill		
Requi	ired Disclosures		
•	☐ If choosing direct cremation or immediate burial, ensure funeral home discloses embalming is not required		
•	☐ If embalming is required for viewing, ask for clear explanation why		
•	☐ Get disclosure in writing of any embalming requirements		

## ✓ YOUR CREMATION RIGHTS

Alternative Containers
•   Know you have the right to use an unfinished wood box or alternative container
• □ Confirm you do NOT need to purchase a casket for direct cremation
• ☐ Ask to see the least expensive container options
• Urrify any crematory-specific requirements and their reasons
Cremation-Specific Disclosures
•   Request information about the cremation process
• □ Confirm what container is actually required vs. suggested
• □ Review all cremation-related fees separately
/ WHAT FUNERAL HOMES CANNOT DO
Prohibited Practices to Watch For
• □ Cannot claim embalming is required by law (when it's not)
• □ Cannot claim you must buy a casket for cremation (when you don't)
• □ Cannot require casket purchase to use their services
• □ Cannot misrepresent state or local legal requirements
• □ Cannot charge for services you didn't approve
• □ Cannot refuse outside caskets or urns
• □ Cannot add handling fees for outside purchases
/ REQUIRED DOCUMENTATION YOU SHOULD RECEIVE
Statement of Funeral Goods and Services Selected
• $\square$ Get itemized statement showing everything you selected

•	☐ Verify price of each individual item
•	☐ Confirm items you provided from outside sources are noted
•	☐ Check for any discounts or refunds applied
•	☐ Review total cost before signing anything
•	☐ Keep copies of ALL documentation
✓ YO	UR RIGHT TO ENFORCE PROTECTIONS
If You	Suspect Violations
•	☐ Document the specific violation (date, time, person, what was said)
•	☐ Keep all price lists, contracts, and written communications
•	☐ File complaint with FTC at reportfraud.ftc.gov or call 1-877-FTC-HELP
•	☐ File complaint with your state funeral regulatory board
•	☐ Consider consulting a consumer protection attorney if financial harm occurred
QUES	STIONS TO ASK EVERY FUNERAL HOME
Before	e Making Any Decisions:
1.	☐ "May I have your General Price List to review and keep?"
2.	☐ "Can I select only the specific services I want, or must I purchase a package?"
3.	☐ "Is embalming required by law for my situation, or is it optional?"
4.	☐ "Can I purchase a casket or urn from another supplier?"
5.	□ "Will you charge me a fee if I provide my own casket or urn?"
6.	□ "What is the least expensive casket/urn option you offer?"
7.	☐ "What alternative container options do you have for cremation?"

8.   "Can you provide an itemized written estimate before I make any commitments?"
9. □ "Which services are required by law vs. optional?"
10. □ "What is your policy if I want to cancel or modify services?"
COST-SAVING REMINDER CHECKLIST
• □ Compare prices from multiple funeral homes
• Consider direct cremation or immediate burial (typically least expensive)
• □ Purchase caskets/urns online or from third-party retailers
• □ Decline embalming if not having viewing/visitation
• Use alternative containers for cremation
• □ Select only services you truly want
•   Hold memorial service at home, church, or community center instead of funeral home
• ☐ Ask about veteran benefits if applicable
