

Legal authority as executor doesn't guarantee technical access. RUFADAA gives you the right to access digital assets, but you still need actual credentials. This workbook helps you navigate both the legal process and the technical reality.

#### **PLATFORM ACCESS POLICIES:**

Facebook/Instagram: Request memorialization or deletion through Meta deceased user policies

Twitter/X: Submit deceased user report with death certificate LinkedIn: Accounts automatically deleted upon notification of death

TikTok: Report deceased user through support system

#### **LEGAL WARNING:**

Do not access accounts using found credentials. This violates the Computer Fraud and Abuse Act (federal law) and platform terms of service. Use official deceased user procedures even though they are slower.

#### **IMMEDIATE ACTION REQUIRED:**

Online businesses die quickly without maintenance. Within 30 days:

- 1. Renew all domain registrations and hosting
- 2. Maintain payment processors and merchant accounts
- 3. Update email addresses to prevent service cancellations
- 4. Consider hiring someone to maintain operations during probate
- 5. Document all revenue sources and expenses for estate accounting

#### **DIGITAL ASSET ACCESS TRACKER**

Document every access attempt and outcome. This becomes your liability protection if questioned later.

Downloaded all photos from cloud storage
Saved important emails and messages

Transferred domain names to permanent ownership
Backed up business data and customer information
Saved NFT ownership records and marketplace screenshots

#### PROFESSIONAL HELP NEEDED:

Cryptocurrency recovery specialist (if holdings over \$10,000)
Digital forensics firm (for locked devices with valuable data)
Probate attorney with RUFADAA experience
CPA for cryptocurrency tax reporting
Business valuation specialist (for online businesses)
