How to Use This Toolkit

This toolkit guides you through the complete process of finding, evaluating, and selecting a special needs estate planning attorney. Use it systematically:

SECTION 1: Understanding Real Expertise

What Real Special Needs Expertise Looks Like

Attorneys with genuine special needs expertise demonstrate these characteristics:

- They ask detailed questions about your child's specific benefits before discussing trusts
- They understand SSI/Medicaid rules deeply and can explain the \$2,000 asset limit without hesitation
- They immediately address family coordination as essential, not optional
- They explain first-party vs. third-party trusts clearly including Medicaid payback differences
- They focus on benefit protection over tax minimization
- They're members of the Special Needs Alliance or hold CELA certification
- They spend 30%+ of their practice on special needs cases

RED FLAGS: Warning Signs to Watch For

These warning signs indicate an attorney lacks real special needs expertise:

- Doesn't ask about your child's specific benefits
- Focuses primarily on taxes rather than benefit protection
- Offers unusually low fees (\$500-\$800)
- Never mentions family coordination importance
- Can't explain SSI asset limits when asked
- Quickly pivots to selling insurance products
- Claims 'all special needs trusts are basically the same'
- Seems annoyed by your questions
- Pressures immediate decisions

Credential	What It Means
Special Needs Alliance	GOLD STANDARD - National organization focused specifically on disability and public benefits law
CELA Certification	STRONG INDICATOR - Board certified in elder law including special needs planning
NAELA Membership	GOOD SIGN - Member of elder law attorney association with special needs focus

Most Important: What percentage of their practice is devoted to special needs work? This matters more than credentials alone.

Essential Questions to Ask

Ask these questions during every consultation. Their answers reveal real expertise:

Question	What a Strong Answer Includes
What percentage of your practice is special needs planning?	30-50%+ of practice. This isn't occasional work.
Are you a member of the Special Needs Alliance or CELA certified?	Yes to either, ideally Special Needs Alliance.
Explain the difference between first-party and third-party special needs trusts.	Clear explanation of funding sources, Medicaid payback, age restrictions.
How do you handle family coordination?	Provides info sheets, speaks with family attorneys, systematic process.
What happens if my child receives unexpected inheritance?	Emergency first-party trust protocol, court petition, speed is critical.
How do you charge and what's included?	Transparent fee structure. Typical: \$2,500-\$5,000+ for comprehensive planning.
Can you provide references?	Can connect with parent groups, has families willing to serve as references.

Final Decision Framework

Consider these factors when making your final choice:

- **Technical expertise is non-negotiable.** Without real special needs knowledge, nothing else matters.
- **Don't choose based solely on price.** Cheapest option may cost far more if planning is inadequate.
- Trust matters. You're entrusting this attorney with your child's financial security.
- **Communication is critical.** You'll work with this attorney for years. Choose someone who explains clearly.
- Any red flags = walk away. Don't rationalize warning signs. Find someone else.

SECTION 6: Cost Expectations Reference

Cost Range	What It Means	
\$500-\$1,500	DANGER ZONE: Likely boilerplate documents or insurance sales pitch. Be very wary.	
\$2,500-\$5,000+	TYPICAL RANGE: Comprehensive special needs planning including trust, coordination guidance, documents.	
\$6,000+	HIGH BUT MAY BE JUSTIFIED: Complex situations, major metro areas, highly experienced specialists.	

What comprehensive planning typically includes:

- Trust drafting (third-party special needs trust)
- Will preparation
- Powers of attorney (financial and healthcare)
- Healthcare directives
- Guardian nomination documents
- Family coordination information packet
- Letter of intent guidance
- · Initial consultations and benefit analysis
- Document review meeting

By completing this toolkit, you've systematically evaluated attorneys, asked the right questions, and made an informed decision. You've protected your child from attorneys who lack real expertise or who might exploit your vulnerability.

What Happens Next

- · Review draft documents carefully when received
- Ask questions about anything unclear
- · Begin family coordination process immediately after documents are signed
